As you may be aware, Public Service Electric & Gas (PSE&G) has been actively upgrading the electric system in order to provide safe and reliable service. This letter is to inform you of the specific work that our crews are completing in your Westfield neighborhood.

As part of this upgrade, existing circuits are being rerouted, along with the installation of new utility poles and new electric wires along an existing pole line. The work is expected to last several weeks in each neighborhood and reach completion in May 2022.

A section of this project runs along the following streets:

- E. Broad Street (between Mountain Avenue and S. Chestnut Street)
- Linden Avenue (between Kimball Avenue and E. Broad Street)
- Jefferson Avenue (between Kimball Avenue and E. Broad Street)
- Winyah Avenue (between Linden Avenue and Wychwood Road)
- Gallowae (from Wychwood Road to dead end)
- Scudder Road (from Gallowae to dead end)
- Canterbury Road (between Wychwood Road and Winyah Avenue)
- Canterbury Lane (between Winyah Avenue and Canterbury Road)
- Baker Avenue (between Winyah Avenue and Saunders Avenue)
- W. Dudley Avenue (between N Avenue W and Prospect Street)
- E. Dudley Avenue (between Prospect Street and Lawrence Avenue)
- Elm Street (between E. Dudley Avenue and Orchard Street)
- Kimball Avenue (between Elm Street and Lawrence Avenue)
- Walnut Street (between Elm Street and Lawrence Avenue)
- Prospect Street (between W. Dudley Avenue and Lincoln Road)

Tree Maintenance: In advance of the overhead construction activities, we will trim and/or remove trees along the route in compliance with the Board of Public Utilities' Vegetation Management Rules. This may include trees in the public right-of-way and on private property. If you are the owner of a tree on private property, you will be contacted by our Vegetation Management Department or one of our approved contractors to discuss the scope of this work.

Safety is our highest priority. Therefore, it is essential that you and everyone using your property, including children and pets, refrain from going near our construction work zones.

In light of the COVID-19 pandemic, and in the interest of maintaining the safety of our customers, our employees, and their families, PSE&G workers and PSE&G contractors follow safety guidelines put into place by the CDC and NJ State Department of Health, as well as all directives from the Governor's Office and county/municipal governments. This

includes that our workers practice social distancing and we ask that you also maintain a safe distance from our crews. PSE&G will not need to enter your home or business as a result of this work.
